#### **SECTION-I**

#### **INSTRUCTION TO BIDDERS**

- 1. Online tenders in conformity with detail tender call notice are invited from the service provider Agencies/Firms having valid Firm Registration Certificate, EPF Registration, ESI Registration, Labour License, GST Registration and PAN and having similar line of business for not less than 3 (three) years towards supplying manpower of high skilled categories in Govt Organization. The service providers should have local Offices at Patna to ensure satisfactory fulfillment of contractual obligations.
- 2. The tender document can be obtained from the office of Managing Director, Bihar State Text Book Publishing Corporation Ltd, Budha Marg, Patna on payment of Rs 1180/-(One Thousand One Hundred Eighty Only) in cash or downloaded from the website <a href="https://www.bstbpc.gov.in">www.bstbpc.gov.in</a> of Bihar State Text Book Publishing Corporation Ltd. Bidders are requested to refer the E-Tender notice for all important dates. Bidders shall have to deposit Earnest Money Deposit of Rs.10,000/- (Rupees Ten Thousand only) as Bid security in the form of Demand Draft obtained from any Nationalized Bank, in favor of Bihar State Text Book Publishing Corporation Ltd, Payable at Patna and submitted along with the Technical BID.

#### 3. **BID QUALIFYING CRITERIA**

The bidders shall be eligible for qualifying to financial section subject to the following:-

- The agency must be registered with Labour Department for exclusive manpower supply work. The bidders having experience of supplying manpower in private organization will not be considered.
- ii. The minimum average annual turnover of the agency/firm concluding with FY 2017-18 should not be less than 200 Lakhs. The bidders are required to submit the audited balance sheets along with P/L Account for the last three FYs i.e; 2015-16,2016-17 & 2017-18.
- iii. The agency/firm must have experience of supplying high skilled manpower of different skills in State/Central Govt bodies/PSU/Banks in last three years.
- iv. The bidders must have executed work of
- v. manpower supply for not less than 50 Lakhs per annum in last three financial year concluding with 2018-19. All relevant Work Orders of past three years between April 2016 to March 2019 and its Work Completion Certificate are mandatorily to be submitted.
- vi. The agency/firm must have valid PAN Number, ESI Registration Number, EPF Registration Number, Labour License and GST Registration Number.

- vii. The agency need to submit the EPF return for the last three months i.e; from May'19 to July'19 along with the technical bid.
- viii. The agency/firm has to submit the Bank Solvency Certficate for Rs 50 Lakhs.
- ix. The agency has to submit the affidavit in support of declaration towards non-blacklisting/Debarr in any Govt/Private/PSU/Bank etc.
- x. All bidders are sincerely requested to upload very clear and readable documents. Since this is e-tendering hence any missing document as per above list in the technical bid shall held the bid for rejection and no additional/supporting documents with respect to missing ones will be entertained in offline mode later during opening of bid or afterwards.
- xi. Bidder to sign and stamp on each and every documents and also on each pages of bid document before scanning and uploading on website failing which bid shall be rejected.
- 4. All bidders are requested to note these under mentioned points following very strictly and carefully:
  - i. That scanned copy of all documents as listed in SI No-3 above and Annexure-I to be uploaded in the technical bid through e-procurement portal.
  - ii. However only original EMD, Fee receipt of Tender Document, Online Tender processing fee and affidavit for non blacklisting to be submitted in hard copy in the office of Managing Director, Bihar State Text Book Publishing Corporation Ltd on 23.09.2019 by 14:00 Hrs.
  - iii. Bidders to note that non-submission/Late Submission of hard copies as mentioned in SI 4 (ii) above within stipulated time and date shall liable the bids for rejection and no queries in this regard shall be admissible in any circumstances.
  - iv. No other documents should be submitted in offline mode other than mentioned at SI 4 (ii) strictly in order to save paper and time for all concerned.

#### 5. BID REJECTION CRITERIA

- i. The tender shall be submitted online only
- ii. All documents as per SI No 3 above should be mandatorily uploaded. Failing to upload any document shall liable the bid for rejection.
- iii. Non Compliance of SI 4 above shall lead the bids for rejection.
- iv. The tender shall be consisting of two parts. The first part will be technical bid and second part will be financial bid.
- v. Incomplete and conditional tenders shall not be accepted.
- vi. If all pages of the technical bid is not properly signed by the bidder

- 6. The Tender Committee will assess the ability of the agencies to render the requisite services based on its past record, profile and on such other criteria as per attached annexure and only those found technically fit will be eligible for financial bid opening.
- 7. Submission of more than one tender paper by a bidder for a particular work will render the bid liable for rejection.
- 8. The bidders may assess about the nature and quantum of work before quoting their rate.
- 9. The rates for different category of manpower that may be required for the proposed services shall not be less than the rates of minimum wages prescribed by the Government of Bihar from time to time under Contract Labour (R&A) Act-1970 and the Minimum Wages Act 1948. Bidders quoting less than the threshold minimum wages shall be summarisely rejected.
- 10. The supervision charges, rate of wages, statutory dues and other allowances etc. under the labour law and other laws will be payable by the bidder and rate breakup shall be taken by BSTBPCL during evaluation of the financial bid.
- 11. The bidders are required to quote their rates both in words, figures, and put their signature; they should also sign on any overwriting or any correction made in the tendered rate. The rates quoted in words will prevail in case of any ambiguity between figure and word.
- 12. Conditional tenders will not be accepted under any circumstances by the authority. EMD deposit of unsuccessful bidders will be refunded within 90 days after finalization of Tender without interest.
- 13. The Bank Demand Draft produced in relation to this tender should be drawn on any Nationalized Bank in favour of the BIHAR STATE TEXT BOOK PUBLISHING CORPORATION LTD., PATNA, payable at Patna. Other details can be seen in bidding document. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
  - A. This office reserves the right to:
    - a) Accept / Reject any of the tender in full or part thereof.
    - b) Revise the requirement at the time of placing the order.
    - c) Add, modify, relax or waive any of the conditions stipulated in the tender specification wherever deemed necessary.
    - d) Reject any or all the tenders in part or full without assigning any reason thereof.
    - e) Award contracts to one or more bidders for the items covered by the tender.

#### 14. Bid Evaluation Critera

a) The Hard copy of EMD, Tender Document fee, Tender Processing fee and affidavit in respect of not blacklisting shall be verified before opening of technical bid. Bidders successful in this stage shall be eligible for opening of their technical bid online.

- b) The technical bid shall be examined based on the checklist provided vide Annexure I. Bidders qualifying 100% with respect to the checklist shall only be eligible for opening of price bid.
- c) Only the bidder quoted lowest price shall be awarded with the work.
- d) The bidders who would have considered zero consideration towards agency's service charge shall be disqualified and their bid shall be rejected in line with CVC norms.
- e) In case two bidders quote same price then the bidder having more average annual turnover in last three years shall be given preference and awarded with the work.
- f) The agencies quoting less than minimum wages as per Gazette of Bihar shall be straightway rejected.
- 15. The Managing Director reserves the right to reject or cancel the tender or any part thereof without assigning any reasons thereof.

#### **SECTION II**

#### **GENERAL & SPECIAL TERMS OF CONTRACT AND SCOPE OF WORK**

#### 1. **SCOPE OF WORK**:

- a) The agency shall have to provide Installation of computer sets with UPS, Laser Printer with cartridge.
- b) The Maintenance of computers sets and printers etc will be in the scope of the agency and no separate cost would be admissible.
- c) The agency has to obtain insurance for manpower and the supplied assets. In case of any accident, the damage caused to man and machine shall be the sole responsibility of agency and no compensation of any kind shall be paid by BSTBPCL.
- d) The successful agency shall provide qualified and experienced computer operators. Apart from the above, the CV of each computer as well as tally professionals to be submitted before deployment in the office.
- e) The agency has to submit the purchase invoice copy of the Computers and its accessories at the time of supply.
- f) All consumables shall be under the scope of the agency.
- g) The working hrs for the professionals shall be from 9:30 Hrs to 18:00 Hrs on all working days of BSTBPCL. The holidays of BSTBPCL shall be applicable for the operators.
- All leaves of the operators shall be sanctioned by the authorised person of BSTBPCL as communicated during course of contract.
- i) In case on non performance or any complaint of the competent authority, a penalty
   @10% of the operator cost per month shall be applicable.
- j) The agency has to submit the Monthly Tax invoice supported with wages sheet, EPF Challan and EPF return of previous month every month for processing of the bills. The bills has to be placed before MD, BSTBPCL latest by 15th of every month. The bill shall be released within 45 days from the date of submission.

#### 2. Special Conditions:

- i. The initial period of contract would be one year.
- ii. However the contract is extendable by another one year on satisfactory performance with such amendments as may be mutually agreed to and also subject to the necessary approval of the competent authority.
- iii. Merely satisfactory performance will not make the agency eligible for contract extension. The extension of contract would be on sole discretion of competent authority.

- iv. Agency Service charges/rates quoted by the agency would be fixed for a period of one year and any statutory increase in wages/DA etc. is to be absorbed by the agency.
- v. For every 5(Five) days of duty of personnel, two days off with payment will be given. The successful agency will have to bear cost of providing personnel for this weekly off. The total monthly rates quoted shall inclusive off all these, including profits, overheads, bonus, gratuity etc and taxes whatsoever payable.
- vi. Bihar State Text Book Publishing Corporation Ltd. will be follow the rule of Stores Purchase Preference Policy, 2002, Department of Industries, Govt. of Bihar, Patna.
- vii. In case of any dispute or ambiguity in the contract during or after the contract period, the Additional Chief Secretary/Principal Secretary/Secretary, Education Department, Govt. of Bihar shall be the sole Arbitrator in line with Arbitration act 1996.
